**NOTICE TO PERSON PROVIDING BAIL MONEY
OTHER THAN THE DEFENDANT**

CERTIFICATE OF DEFENDANT

I, the defendant named above, do hereby state that I know and understand the terms and conditions of this bail bond as shown on this bail bond form. I acknowledge that I received a copy of this bail bond form. I understand further that if any time prior to the final disposition of the charge(s) I escape or am released on bond, and fail to appear in court when required by the court, the result will be as follows: I waive my right to confront the witnesses against me; the trial can proceed in my absence; I forfeit the security money posted; judgment will be entered against me for the full amount of this bond, plus costs; a warrant may be issued for my arrest, in which event additional bond may be required.

I, the undersigned defendant do hereby acknowledge myself to be indebted to the People of Illinois or the City or Village set forth as a municipal corporation in the sum indicated as bail. I shall comply with the conditions of the bail bond set forth, if a 10% bond is posted it shall upon order of Court be discharged and said defendant shall be entitled to the return of 90% of said deposit, the remaining 10% of said deposit to be retained by the Clerk of this Court as bail bond costs; provided, however, that in the event a judgment is entered against said defendant for a fine and/or court costs, the balance of said deposit, after deduction of bail bond costs, shall be applied to the payment of said fine _____ and/or court costs. If said defendant shall fail to comply with said conditions of his bail, his bail shall remain in full force and effect and said defendant shall be liable for forfeiture thereon.

CONDITIONS OF BAIL

1. I will appear to answer this charge in the Court having jurisdiction of the day certain set for hearing of this cause and thereafter as Ordered by the Court until discharged, and will abide by the Order of the Court.
2. I will submit myself to the Orders and process of the court; and
3. I will not depart this State without leave of this Court while this cause is pending in this Court.
4. I shall give written notice to the Clerk of the Court of any change of address within 24 hours after such change.
5. I will not violate any criminal statute of any jurisdiction.
6. I understand that a copy of this instrument is my receipt for the bond amount deposited herein.
7. I will within 24 hours of release surrender all firearms in my possession with an agency/party when directed.

When a person is charged with a criminal offense, and the victim is a family or household member as defined in 725 ILCS 5-112A-3, conditions of bond shall be that:

- 1) the defendant shall refrain from contact or communication with the plaintiff for a minimum period of 72 hours following defendant's release, and
- 2) the defendant shall refrain from entering or remaining at the plaintiff's residence for a minimum period of 72 hours following defendant's release.

"Family or household members" include spouses, former spouses, parents, children, stepchildren and other persons related by blood or by present or prior marriage, persons who share or formerly shared a common dwelling, persons who have or allegedly have a child in common, persons who share or allegedly share a blood relationship through a child, persons who have or have had a dating or engagement relationship, and persons with disabilities and their personal assistants. For purposes of this paragraph, neither casual acquaintanceship nor ordinary fraternization between 2 individuals in business or social contexts shall be deemed to constitute a dating relationship.
