Any knowing violation of a firearms restraining order is a Class A misdemeanor and shall not bar concurrent prosecution for any other crime, including any crime that may have been committed at the time of the violation of the firearms restraining order.

The respondent does pose an immediate and present danger of causing personal injury to himself, herself, or
another by having in his or her custody or control any firearms; or purchasing, possessing, receiving
additional firearms. (430 ILCS 67/35)

IT IS ORDERED the following remedies that are checked apply in this case. □ 1. (R01) For the duration of this order, Respondent shall be prohibited from having in his or her custody or control any firearms, and is further prohibited from purchasing, possessing, or receiving additional firearms. □ 2. (R02) Respondent shall turn over to the local law enforcement agency any Firearm Owner's Identification Card (FOID) and concealed carry license in his or her possession. If the Court finds probable cause to believe that the Respondent is in possession of firearms, then (1) the Court SHALL issue a warrant for the seizure of the firearms; and (2) the Court MAY issue a search warrant to locate the firearms. - 1. **Family members:** Includes a spouse, parent, child, step-child, any other person related by blood or present marriage, or a person who shares a common dwelling with the respondent.
- 2. **Firearms Restraining Order:** "FRO" means an order issued by the court, prohibiting and enjoining a named person from having in his or her custody or control any firearms, and purchasing, possessing, or receiving, additional firearms.
- 3. **Intimate partner:** Includes a spouse, former spouse, a person with whom the respondent has or allegedly has a child in common, or a person with whom the respondent has or has had a dating or engagement relationship.
- 4. **Petitioner:** "Petitioner" means a family member or a law enforcement officer.
- 5. **Respondent:** "Respondent" means the person alleged in the petition to pose a danger of causing personal injury to him/her self, or another by having in his or her custody or control any firearms, and purchasing, possessing, or receiving additional firearms.
